

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to braincellacademy.com, and BrainCell, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to BrainCell, LLC include braincellacademy.com. The BrainCell, LLC website is a Tutoring Service site. By using the BrainCell, LLC website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, BrainCell, LLC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address

If you purchase BrainCell, LLC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
